## School Annual Education Report (AER) Cover Letter

For the 2016-17 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as a "has not been given one of these labels."

E.B. Holman School being a small rural school faces many challenges, most being budgetary in the form of unfunded mandates. Academically, the school has done well maintaining consistent test scores throughout the grade levels. The teachers and staff continue to collaborate, and are consistently working together aligning and adopting curriculum to incorporate state academic standards. We are also preparing students for M-Step online testing by introducing technology into daily instruction. The entire school improvement plan can be found online.

## IMPLEMENTING THE CORE CURRICULUM

At Stanton Township Public Schools, teachers are engaging the Michigan core curriculum. In 2001-02 Stanton Township Public Schools adopted the Michigan Frameworks as official curriculum. The core curriculum guides continue to be developed and reviewed on a regular basis by a site-based committee. Students are receiving instruction in the areas of physical education, the arts, careers and employability skills; however, development of the formal curriculum and aligning the objectives by grade level is and has been a continual process. Our approach to implementing the curriculum is becoming more integrated. Math concepts are being reinforced in science units, spelling rules are being covered in reading lessons; the writing process is part of any subject area lessons. 
